SPECIAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That LARRY D. SHANNON

, hereinafter called grantor,
for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto
DR. GEORGE ADAMS

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the
tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County
of Klamath, State of Oregon, described as follows, to-wit:

A tract of land situated in Section 10, T.35S., R.11 E., of the W.M., in the
County of Klamath and State of Oregon described as follows:

Beginning at the Northeast corner of Lot 4, Block 12 of OREGON PINES, a duly
recorded plat, said corner being on the Southerly line of the Southeast one-
quarter of the Northwest one-quarter of said Section 10; thence South 88°47'27"
East along the Southerly line of the Southeast one-quarter of the Northwest one-
quarter of said Section 10, a distance of 1082.16 feet to the Southeast corner
thereof; thence North 0°51'44" East along the Easterly line of the Southeast one-
quarter of the Northwest one-quarter of said Section 10, a distance of 420.00
feet; thence South 89°08'16" East a distance of 865.00 feet; thence South
04°53'43" East a distance of 1095.07 feet to the most Southerly Southwest corner
of a tract of land described in a Contract to Len K. Osborn, recorded October 21,
1977 in Volume M-77, Page 20282, Deed Records and the true point of beginning
of the tract of land herein to be described; thence continuing South 04°53'43"
East a distance of 982.96 feet; thence South 76°33'23" West a distance of
650.00 feet to the most Northerly corner of Lot 84, Block 18 of said plat; thence
along the exterior line of said plat the following courses: South 62°26'30"
East a distance of 1578.54 feet; thence North 27°27'19" East a distance of
