

DESCRIPTION

A parcel of land situate in the SE $\frac{1}{4}$ of Section 10, Township 34 South, Range 9, E.W.M., Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the north-south centerline of said Section 10 from which the S $\frac{1}{4}$ corner of said Section 10 bears S 00° 13' 18" E 1438.18 feet, thence from said point of beginning N 00° 13' 18" W along the north-south centerline of said Section 10 330.00 feet to a point, thence S 46° 46' 19" E 854.29 feet to a point on the northwesterly right of way of the Head of the Williamson Road, thence along the northwesterly right of way of said Head of the Williamson Road S 37° 18' 19" W 37.02 feet to a 5/8" iron pin, thence continuing along the northwesterly right of way of said Head of the Williamson Road and along the arc of a 1382.40 feet radius curve to the right (Delta = 12° 07' 14" chord = 291.89 feet) 292.44 feet to a point, thence leaving northwesterly right of way of said Head of the Williamson Road N 41° 42' 22" W 598.41 feet to the point of beginning.
