KNOW ALL MEN BY THESE PRESENTS, That First State Bank of Oregon, Trustee for Marion D. Thomas Keogh Plan fbo Participants, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Richard D. Thomas as to an undivided 80% interest and Larie A. Thomas as to an undivided 20% interest, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The E1/2, NE1/4, NE1/4, SW1/4 of Section 16, Township 28 South, Range 8 East of the Willamette Meridian, in the County of Klamath, State of Oregon, less that portion lying in the right of way of U.S. Forest Service Road #283 along the Southline.

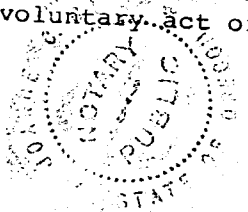
