ADDENDUM TO SUPPLEMENTAL LOAN AGREEMENT
DATED January 14, 1980, RECORDED under Fee No. 79702, Benton County,
in VOLUME M-80, Page 1344, Records of Mortgages, Klamath County

THIS ADDENDUM, made this 11th day of April, 1980,
by and between FRED MEYER SAVINGS & LOAN ASSOCIATION, an Oregon Corporation,
hereinafter called "First Party", and DON E. DENLINGER, LEE H. QUIRING,
S. W. McPHERSON, JOHN F. KUMLEY, MARY A. KUMLEY, GLEN R. DURHAM and
SIBYLL G. DURHAM, hereinafter called "Second Parties".

WITNESSETH That:

WHEREAS, The First Party committed a loan to the Second Parties
on March 25, 1980, in the amount of \$150,000.00, ~~with a twelve month~~ ^{term}
~~term~~, on the two 4-plexes located at 2473 S. W. Pickford and 2479 S. W.
Pickford, Corvallis, Oregon 97330, for construction. This Agreement
heretofore attaches itself to the original loans and shall be a part of
the cross-collateralization agreement, also known as, the Supplemental
Loan Agreement, dated January 14, 1980, and recorded under Fee No. 79702,
in Record of Mortgages in Benton County, and Volume M-80, Page 1344,
Record of Mortgages in Klamath County.

THE PARTIES THEREFORE agree that any default upon the Trust
Deed on Loan No. 20-161343-8, Hereinafter called the Two-Four Plexes,
shall be deemed a default upon the Cinnamon Park trust deeds and against
the Motel Property in Klamath County, and any default upon the Cinnamon
Park trust deed in Benton County will be deemed a default upon the Two-
Four Plexes and the Motel Property in Klamath County, and a default upon
the said Motel Property shall be deemed a default upon the Two-Four Plexes
and the Cinnamon Park Trust Deeds, and in any one of these events, or any
combination of them, shall permit the First Party to pursue any or all of
its remedies provided in said trust deeds and mortgage, concurrently or
consecutively, separately or in a single suit or action, for as long as
such delinquency shall continue with respect to either or any of said
security instruments. This Agreement attaches itself to and is a part of
the original loans and cross-collateralization agreement, also known as
the Supplemental Loan Agreement, more particularly described in the
preamble above setforth.

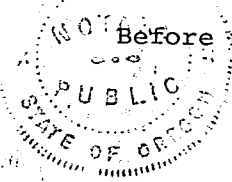

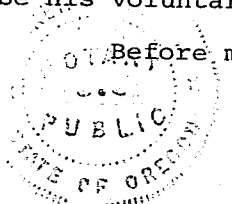

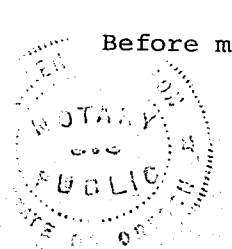
