THIS INDENTURE, WITNESSETH, That MONTE D. BECKMAN and GARY A. WILLIAMS, herein called "grantors", in consideration of the sum of TWENTY-SIX THOUSAND FOUR HUNDRED AND NO/100 DOLLARS to them paid, have bargained and sold and by these presents do grant, bargain, sell and convey to JELD-WEN, inc., an Oregon corporation, THOMAS LUMBER COMPANY DIVISION, herein called "grantee", its successors and assigns forever, all of the merchantable timber which measures over 16 inches in diameter, measured outside the bark at a height of $4\frac{1}{2}$ feet above average ground level, which timber now is growing upon the followingdescribed real property, situated in Klamath County, Oregon, of which grantors are the owners in fee simple and in possession of, to-wit:

Grantee, in accepting this grant, agrees that it will pay all taxes and assessments levied or charged by reason of the cutting and removal of said timber.

It is acknowledged that grantee, in cutting and removing said timber, is and shall be deemed to be an independent contractor and not

an agent, employee or representative of grantors, or either of them. Grantee shall conduct the cutting and removal of said timber in strict compliance with all applicable rules, regulations and statutes of the United States of America, the State of Oregon and Klamath County.

Grantee is granted the right of access to said real property, and each part thereof, for the purpose of cutting and removing said timber.

All of said timber shall be cut and removed from said premises within six months from the date of this deed, which time limit is subject to being extended in accordance with an agreement between the parties hereto of even date.
