KNOW ALL MEN BY THESE PRESENTS, That

GEORGE A. PONDELLA JR.

for the consideration hereinafter stated to the grantor paid by CLOYD L. BRILEY hereinafter called the grantor,

hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of KLAMATH, State of Oregon, to-wit:

NORTHWEST $\frac{1}{4}$ of SOUTHWEST $\frac{1}{4}$ of SECTION 4, TOWNSHIP 37 SOUTH, RANGE 12 EAST, W.M.

This conveyance is made subject to easements, rights of way of record and those apparent on the land and Grantor reserves an easement for joint user roadway and all other roadway purposes over and across a 30 ft. wide strip of land laying south of adjoining and parallel to the northerly boundary and laying east of adjoining and parallel to the westerly boundary.

This deed made to replace contract of sale dated September 19, 1969.

TO HAVE AND TO HOLD the above described and granted premises unto the said grantees, their assigns and the heirs of such survivor, forever; provided that the grantees herein do not take the title in common but with the right of survivorship, that is, that the fee shall vest absolutely in the survivor of the grantees.

And the grantor above named hereby covenants to and with the above named grantees, their heirs and assigns, that grantor is lawfully seized in fee simple of said premises, that same are free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 2,520.00
