1. SUBORDINATION: Mortgagee hereby covenants, consents, and agrees with Lender that the aforesaid mortgage held by mortgage is and shall continue to be subject in lien to the lien of the mortgage about to be made to Lender as aforesaid.

2. This agreement shall be binding upon and inure to the benefit of the respective heirs, legal representatives, successors, and assigns.
