

One acre of land in the NE%SW% of Section 7, Township 38 South, Range 9 East of the Willamette Meridain, in Klamath County, Oregon, more particularly described as follows: Beginning at the center of said Section 7, thence North 89°49' West 480.5 feet to the intersection with the West line of the Dalles-California Highway; thence South 6°02' West along said West line of the Highway 870.3 feet to the Northeast corner of the property herein conveyed; thence North 89° 49' West, 486.54 feet; thence South 6°02' West 90.0 feet; thence South 89°49' East, 486.54 feet to the West line of the said Highway; thence North 6°02' East along said Highway 90.0 feet to the point of beginning.

Beginning at a point on the Westerly right of way line of the Dalles-California Highway, which point is 1627.2 feet North 6°02' East from a point on the Section line between Sections 7 and 18, Township 38 South, Range 9 East of the Willamette Meridain, said point being 770.8 feet North 89°49' West fron the one-quarter section corner between Sections 7 and 18; running thence North 89°49' West 486.54 feet; thence North 6°02' East 90.0 feet; thence South 89°49' East 486.54 feet; thence South 6°02' West 90.0 feet to the point of beginning. Said parcel containing one acre, more or less in the NE½SW½ of Section 7, Township 38 South, Range 9 East of the Willamette Meridain, Klamath County, Oregon.
