KNOW ALL MEN BY THESE PRESENTS, That LAVERNE L. HANKINS and CHRISTINE Y. HANKINS, husband and wife, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by LLOYD L. HANKINS and IOLA W. HANKINS, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A one acre portion of land located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 7, Township 39 South, Range 11 East, W.M., Klamath County, Oregon, more particularly described as follows: Commencing at a point on the South line of SE $\frac{1}{4}$ SW $\frac{1}{4}$ which lies distant 540 feet from the Southwest corner of said "40," and running thence North at right angles to said South line 208-3/4 feet; thence East parallel with said South line 208-3/4 feet; thence South at right angles to said South line 208-3/4 feet to said South line; thence Westerly 208-3/4 feet to the point of beginning.

THIS DEED IS MADE TO CORRECT THAT CERTAIN WARRANTY DEED DATED NOVEMBER 30, 1979, RECORDED JANUARY 3, 1980, IN VOLUME M-80, PAGE 159, OFFICIAL RECORDS OF KLAMATH COUNTY, OREGON.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
