The S½NE¼ and Lots 3 and 4, and that part of Lot 2 lying North and East of the Dalles-California Highway, all in Section 24, Township 41 South, Range 12, E.W.M.

Subject to reservations, restrictions, rights of way of record and those apparent upon the land; The assessment roll and tax rolls disclose that the within described premises were specially assessed as farm land; Acreage and use limitations under provisions of United States Statutes and regulations issued thereunder; Liens and assessments of Klamath Project and Malin Irrigation District, and regulations, contracts, easements, water and irrigation rights in connection therewith.

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.
