

DEED OF PARTIAL RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee, or successor trustee, under that certain trust deed dated June 13, 1980, executed and delivered by Louis F. Lenzo and Carolyn J. Lenzo, husband and wife as grantor and in which Lawrence D. Tidwell and Katherine K. Tidwell, husband and wife is named as beneficiary, recorded June 13, 1980, in book M-80 at page 10935 of the Mortgage Records
