If installation is not installed in a workmanlike manner, Pacific, at no expense to the Homeowners, will cause any deficiencies to be

## 4. HOMEOWNERS' OBLIGATION TO REPAY

Homeowners other than natural persons prior to the sale or transier for consideration of any legal or equinable, interest in any part of the property. Fromeowners other than persons (corporations, trusts, etc.) shall pay to Pacific, without interest, the actual contract cost of the insulation and weatherization within seven years of the date of this agreement. Homeowners may pay such cost to Pacific at any time prior to the time payment is due.
