KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Ten and No/100ths (\$10.00) DOLLARS, and other good and valuable consideration, receipt of which is hereby acknowledged, PAUL A. MONTGOMERY, hereinafter called Assignors, does hereby sell, transfer, set over and assign to WAYNE HORTON, WILLIAM C. RANSON, and JAMES H. PATTON, hereinafter called Assignees, all his right, title and interest in a certain piece of real property, and all right, title and interest in a certain contract dealing with said real property entered into on the 26th day of June, 1973 wherein FRED R. KRAUEL was Vendor, EARNEST L. GROTH and MARIAN J. GROTH, husband and wife, and HAROLD I. KEZER and LOIS DEZER, husband and wife were Vendees; which Contract was subsequently assigned by Assignment of Vendees Interest and by instrument dated April 1, 1977, recorded April 20, 1977 in Book M-77, page 6762, to Assignor. Assignor is hereby selling, transferring and assigning to the Assignees, all of his right, title and interest therein of the following described property situate in Klamath County, Oregon, to-wit:

A portion of the NE¹/₄NW¹/₄ of Section 32, Township 38 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows: Beginning at a point North 38° 56' East 60 feet distant from the Northeasterly corner of Block 82 in KLAMATH ADDITION TO THE CITY OF KLAMATH FALLS, OREGON: thence South 51° 4' East 120 feet; thence North 38° 56' East 60 feet; thence North 51° 4' West 120 feet; thence South 38° 56' West 60 feet to the point of beginning

It is agreed for the consideration above recited by and between Assignor and Assignees, the Assignees assume and agree to pay the balance of said contract as determined by the records of Klamath First Federal Savings and Loan Association, Klamath Falls, Oregon, and to in all ways save the Assignor harmless from any obligation thereon.
