RESOLUTION OF THE LANGELL VALLEY IRRIGATION DISTRICT

(1) Under the authority of the provisions of ORS 545.482, Langell Valley Irrigation District, commencing July 1, 1980, shall levy and collect assessments of the District to provide funds for the payment of all costs of operation of the District, to pay operation and maintenance charges, construction, interest and other charges payable under contracts to the United States of America, and principal and interest payments on obligations of the District.

(2) The Board shall, on or before the first Tuesday in April of each year, make a computation of assessment of the amounts of money necessary to be raised by the District for the next ensuing fiscal year for the purpose of providing for the care, operation, maintenance and repair of the District's buildings, facilities and equipment, bond and interest payments, payment due or to become due to the United States under all contracts between the District and all other expenses of the District, including an allowance for delinquencies in collections, and shall assess the lands in the District for the full amount of the money needed for such purposes.

(3) The Board of the District shall sit as the Board of Equalization on the first Tuesday in May of each year to hear and determine any objections by any interested persons to the assessment and apportionment thereof.

(4) The secretary of the District shall give notice, by publication in the Herald and News, a newspaper of general circulation within the District, of the time and place of the meeting of the Board of Equalization. Said notice shall be published four times, once during each of the three weeks immediately preceeding the date of the meeting.

OFFICE AT LORELLA:

- (5) All assessments levied by the District will be paid to, and collected by the secretary, at the District office at Lorella, Oregon.
- (6) Before collecting, handling, or receiving any of said assessments, the secretary of the District shall give a good and sufficient surety bond in the form and through a surety company, acceptable to the Board, in the amount of \$25,000.00, which amount may be amended from time to time by the Board.
- (7) All assessments will be accrued and become a lien on the real property within the District on July 1 of each fiscal year.
- (8) Assessments will be paid at the District office. One half of the assessment will be due on October 15th and will be considered delinquent after November 15th. The second half will be due on March 15th, and will be considered delinquent after April 15th.
- (9) All delinquent assessments shall be charged interest at the rate of 1% per month, or any portion thereof.
- (10) The District will withhold delivery of water to any property for which the assessment or any installment thereon is delinquent, except where the payment of said delinquent assessment has been secured by security satisfactory to the District, or except if the Board shall waive such delinquency to alleviate an extreme hardship, which waiver may be on such conditions as to the Board seem appropriate.
