WARRANTY DEED—TENANTS BY ENTIRETY

KNOW ALL MEN BY THESE PRESENTS, That

ROBERT C. BOUVIA

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by HOMER H. FLOYD and JEAN FLOYD, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lot 26, RIVERS BEND, in the County of Klamath, State of Oregon.

SUBJECT, however, to the following:

1. Restrictions, but omitting restrictions, if any, based on race, color, religion or national origin, as shown on the recorded plat Rivers Bend.
2. Reservations and restrictions, including the terms and provisions thereof, contained in Deed dated May 27, 1963, recorded March 21, 1968 in Book M-68 at page 2215, Microfilm Records.
3. Regulations, including levies, assessments, water and irrigation rights and easements for ditches and canals, of Modoc Point Irrigation District.

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.

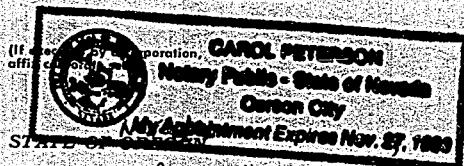
