The first of said installments of \$263.25 shall be paid on the 1st day of August, 1980, and a like payment on the 1st day of each and every month thereafter.

Except as specifically set forth herein, all the terms, conditions and provisions of that certain Contract of Sale and the Assignment thereto, set forth above; shall remain in full force and effect.
