RESOLUTION #28

A resolution adopted by the Board of Directors of South Suburban Sanitary District at the regular monthly meeting held on the <u>5</u> day of <u>August</u>, 1980.

WHEREAS, there are territories contiguous to the boundaries of the South Suburban Sanitary District which are in need of sanitary sewer service, and

WHEREAS, there is hereinafter designated such a territory which is not within the boundaries of any city nor of any other sanitary district formed under the provisions of Chapter 450, Oregon Revised Statutes, and

WHEREAS, considering the economic, demographic and sociological trends and projections pertinent to said area relating to the need for sewer service and to the past and perspective development of the area, it is determined that all of the real property hereinafter described proposed for annexation would be benefitted by such annexation, and

WHEREAS, said area of real property is described as follows: Beginning at the Northeast corner of Tract 10 of Tracts 25 to 32, inclusive of Altamont Ranch Tracts, a platted subdivision located in Section 15, Township 39S, R9E, W.M., in Klamath County, Oregon. Thence South along the East line of Tract 10 to point of intersection with the Northeasterly right-of-way line of Great Northern Railroad; thence Northwesterly along said right-of-way line to a point of intersection with the East right-of-way line of Avalon Street; thence North along said right-of-way line to a point of intersection with the North line of Tract 9; thence Easterly along the North line of Tracts 9 & 10 to the point of beginning, containing approximately 14.80 acres, more or less.

WHEREAS, the owners of all of the real property described above have filed their petition for annexation of said area to the district as appeares more fully from the records and files of the district herein,

NOW THEREFORE, BE IT RESOLVED that the Board of Directors of South Suburban Sanitary District intend to annex the above described tract of real property pursuant to the provisions of Chapter 450 Oregon Revised Statutes, and Chapter 198, Oregon Revised Statutes, and

BE IT FURTHER RESOLVED that this, the district board, proceed further to initiate said annexation by filing a copy of this Resolution with the Board of County Commissioners of Klamath County, Oregon, and request that it set a time and place for a hearing upon this petition;

BE IT FURTHER RESOLVED that pursuant to ORS 198.775(2), the directors hereby obligate the district to pay any and all costs incurred by the Board of County Commissioners in the processing of this petition.
