22189-2D JOINT MEMORANDUM OF CONSENT

TO ACTION OF SHAREHOLDERS AND DIRECTORS

WITHOUT A MEETING

The undersigned, being all of the shareholders and all of the directors of PACIFIC LINEN-MECHANICS UNIFORM SERVICE, INC. (the "Corporation"), hereby consent to the following action taken without a meeting:

Isensee and Esther L. Isensee in the amount of \$60,000.00, said note to be in the form attached hereto as Exhibit

RESOLVED, that following the exercise of the option and the conveyance of the Real Property to Joseph W. Smith and Evelyn C. Smith, the Corporation shall enter into an agreement to lease the Real Property from Joseph W. Smith and Evelyn C. Smith on the terms and conditions contained in the form of Lease Agreement attached hereto as Exhibit B.

RESOLVED FURTHER, that the President of the Corporation is hereby authorized and directed to execute said Lease Agreement on behalf of the Corporation.
