## EASEMENT FOR BURIED CABLE

WEYERHAEUSER COMPANY, a Washington corporation, herein called "Owner," hereby grants to STATE OF OREGON, DEPARTMENT OF FORESTRY, herein called "Grantee," an easement for an underground electric cable across that portion of the NE4NE4 of Section 16, Township 40 South, Range 7 East, W.M., Klamath County, Oregon, located approximately as shown in red on the attached Exhibit A.

Subject as to said lands to all matters of public record.

The terms and conditions of this Easement are as follows:

1. Owner shall have the right to use said strip of land for any purpose not inconsistent with the rights herein granted.

2. Grantee shall have access to the cable for the purpose of exercising the rights herein granted.

3. The location of the electric cable is to be marked by intervisible markers.

4. Grantee hereby waives all claims for damages to its cable which may result from or arise out of Owner's normal operations.

5. Grantee shall pay for all damages to Owner's property resulting directly or indirectly from the negligent acts or omissions of Grantee hereunder.

6. To the extent permitted by Article XI, Section 7 of the Oregon Constitution and by the Oregon Tort Claims Act, the Grantee shall indemnify Owner against any liability for damage to life or property arising from the Grantee's occupancy or use of Owner's lands hereunder; provided, however the Grantee shall not be required to indemnify Owner for any such liability arising out of the wrongful acts of employees or agents of Owner. Provided further, that the agreement to indemnify does not limit any separate legal right or remedy which Owner has against the Grantee.

7. The rights herein granted shall continue until such time as Grantee shall have abandoned the use of the cable located as described herein.
