Beginning at the northwest corner of said deed volume M76, page 3740, from which the northwest corner of said section 10, bears N00°08'00"E 441.59 feet; thence S89°30'57"E, along the north line of said deed Volume M76, page 3740, 200.00 feet; thence S00°08'00"W 33.57 feet to a 5/8-inch iron pin; thence S77°41'42"W 204.80 feet to a 5/8-inch iron pin on the west line of said deed Volume M76, page 3740; thence N00°08'00"E 78.91 feet to the point of beginning., containing 0.26 acres, with bearings based on said deed Volume M76, page 3740.
