at the Company's expense shall remain the property of the Company subject to removal at
its option.

described lands and that the said lands are free from encumbrances and liens of whatever
character except those held by the following persons:

extent, but only to the extent, necessary to subordinate said mortgage(s) to the rights
hereby granted to the Company.

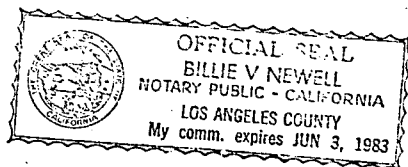

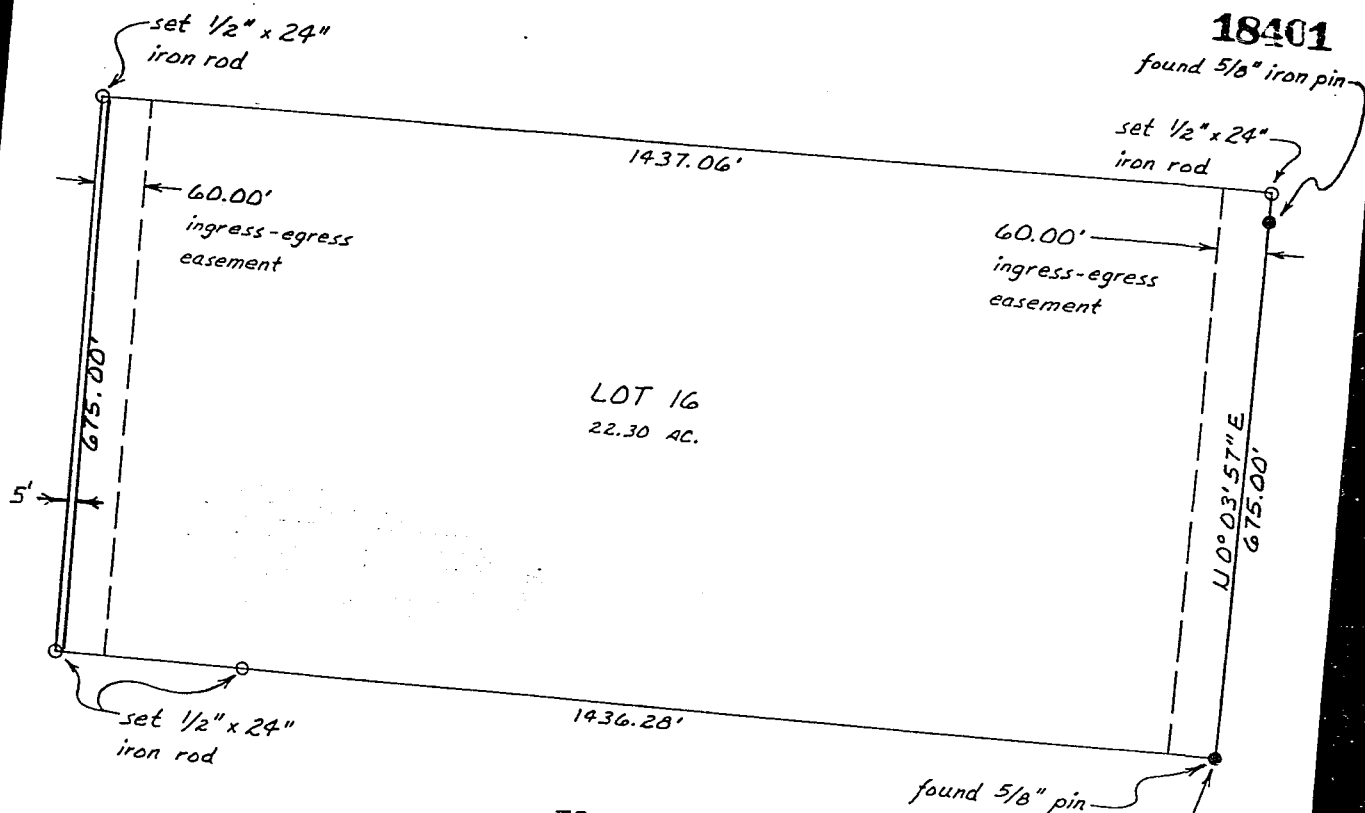
