To: Robert M. Schneider and Jane B. Reigeluth:

The road you presently use for access to your property (see description "A" below) from Sprague River Highway passes over property that we, the undersigned, are purchasing (see description "B" below).

We wish to inform you that said road may be continued to be used for access to your property with the understanding that we retain the right to revoke permission to use said road at any time.

DESCRIPTION "A": A tract of land in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 11, Township 35 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at the Northwest corner of a tract of land conveyed to Laurence Myers and Wife by deed recorded May 31, 1968, in M-68, page 4893, said corner being South 89°21'50" East 1203 feet, north parallel to the west line of said NW $\frac{1}{4}$  a distance of 480 feet, due west 325 feet and due north 559 feet, more or less from the southwest corner of said NW $\frac{1}{4}$ ; thence from said point of beginning running westerly along the southerly line of Sprague Road a distance of 400 feet; thence South parallel to the west line of said Myers tract a distance of 630 feet; thence due east to the west line of said Myers tract; thence North along the west line of said Myers tract to the point of beginning.

DESCRIPTION "B": All that portion of the SW $\frac{1}{4}$ NW $\frac{1}{4}$  and SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 11, Township 35 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Commencing at a point South 89° 21' 50" East 1203 feet from the Southwest corner of the NW $\frac{1}{4}$  of Section 11, Township 35 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon; thence at right angles and parallel to the West line of the NW $\frac{1}{4}$ , North a distance of 480 feet to the true point of beginning; thence due West 325 feet; thence due North 690.78 feet, more or less, to the Southerly right of way line of Sprague River Highway; thence Southeasterly along said right of way line to a point due East from the point of beginning; thence West 360.34 feet, more or less to the true point of beginning.

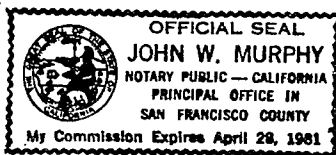

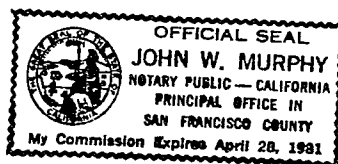
