DECREE

This matter having been heard by the Master for the Superior Court, and Findings of Fact and Conclusions of Law recommending judgment as hereinafter provided having been filed, it is hereby

ORDERED, ADJUDGED AND DECREED:

1. That the plaintiff is granted an absolute Decree of divorce dissolving the bonds of matrimony heretofore and now existing between plaintiff and defendant.

2. That the defendant is awarded the care, custody and control of the minor children of the parties, CRAIG ALLEN ANDERSON and CORINA DAWN ANDERSON.

3. That the plaintiff is awarded reasonable and generous visitation, which shall include extended visitation on alternate weekends, alternate vacation periods, and a period of 6 weeks during regular summer school vacations. That plaintiff shall be responsible for transportation expenses of the children to and from plaintiff's residence. That for so long as defendant reasonably determines that the children are too young to travel alone, plaintiff shall personally pick up and deliver the children to defendant.

4. That the plaintiff shall pay the sum of \$200 per month per child as and for their support until such time as each minor child attains the age of majority or becomes otherwise

3 5. That the plaintiff shall maintain \$40,000 in life
4 insurance with the two minor children named as beneficiaries,
5 with plaintiff to furnish proof of said insurance upon reasonable
6 request.

7 6. That plaintiff is awarded all of the personal
8 property located in Alaska, including plaintiff's 1978 Silverton,
9 except such personal property and effects which belonged to
10 defendant prior to the marriage of the parties.

11 7. That defendant is awarded any real property and
12 all personal property located in Oregon and the sum of \$3,000
13 upon the sale of plaintiff's boat or within 3 months of
14 plaintiff obtaining gainful employment, whichever occurs first.
