KNOW ALL MEN BY THESE PRESENTS, That the undersigned

WAGGONER, as optionee, have entered into an option agreement in writing under date of Acot. 15, 1980, wherein optionor has granted to optionee the exclusive right to purchase the following-described real property, situated in Klamath County, Oregon, to-wit:
