

MEMORANDUM OF OPTION AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, That the undersigned Aloma P. Hull, as optioner, and HARRY R. WAGGONER, as optionee, have entered into an option agreement in writing under date of Sept. 15, 1980, wherein optioner has granted to optionee the exclusive right to purchase the following-described real property, situated in Klamath County, Oregon, to-wit:

A parcel of property located in portions of vacated Blocks 1, 2, 5, 6 and 9, ELDORADO ADDITION to the City of Klamath Falls, Oregon, more particularly described as follows: Beginning at a point being the intersection of the northerly right of way line of Dahlia Street and the northeasterly extension of the southeasterly line of Lot 7, said Block 9; thence N. 51°43'30" W., along the northerly right of way line of Dahlia Street, 211.87 feet thence along the arc of a 2°6.5 degree curve to the right 49.56 feet to a point on the southerly right of way line of Eldorado Boulevard; thence S. 89°34'35" E., along said line, 574.23 feet; thence along the arc of a 8°28'30" curve to the right, whose long chord bears S. 76°04'49" E. 315.82 feet, a distance of 318.86 feet; thence S. 38°16'30" W. 668.38 feet; thence N. 51°43'30" W. 517.00 feet to the southeasterly corner of Lot 7, said Block 9; thence N. 38°16'30" E. along the southeasterly line of said Lot 7 and the extension thereof, 150.00 feet to the point of beginning. ALSO Lots 1 through 6, said Block 9. SUBJECT TO: Right of way, including the terms and provisions thereof, to California Oregon Power Company recorded July 17, 1950, in Deed Volume 240, Page 308, records of Klamath County, Oregon, for electrical transmission lines.
