KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated JULY 11 1979 executed and delivered by WILLIAM J. Beginning at a point on the Easterly right of way line of the Dalles-California Highway which lies North 89°42' West, a distance of 710.5 feet and South 6°02' West a distance of 711 feet from the iron axle which marks the quarter corner common to Sections 7 and 18, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, running thence;

Continuing South 6°02' West along the Easterly right of way line of the Dalles-California Highway, a distance of 144 feet to a point; thence South 89°09' East a distance of 328.04 feet to a point; thence North 6°02' East parallel to the Easterly right of way line of the Dalles-California Highway a distance of 139.75 feet to a point, thence North 88° 25' West, a distance of 327.7 feet, more or less, to the point of beginning; being in the NE¼NW¼ of Section 18, Township 38 South, Range 9 East to the Willamette Meridian, Klamath County, Oregon.
