The Borrower understands and agrees that the interest rate set forth on the Note shall be in effect only if this loan is purchased by the Housing Division, Department of Commerce, State of Oregon or its assigns. In the event that it is not so purchased, for any reason, the interest rate shall then increase to $11 \frac{3}{4}$ % per annum and the monthly installment of principal and interest increased to $\frac{412.36}{4}$
