NOTICE OF DEFAULT AND ELECTION TO SELL

Ellen Lee St. Pierre, as grantor,
made, executed and delivered to Transamerica Title Insurance Co., as trustee,
to secure the performance of certain obligations including the payment of the principal sum of \$19,800.00
