AMENDMENT TO RIGHTS OF REFUSAL

KNOW ALL MEN BY THESE PRESENTS, made this 1st day of September, 1980, that those certain Right Of Refusal Agreements which were recorded in the Deed Records of Klamath County, Oregon, on the following dates and in the following Volumes and pages, to-wit:

- 1. Right Of Refusal executed by Peggy M. Stivers, Jacqueline Jon Sloan and Robert Sloan III, recorded August 21, 1980, in Vol. M-80 at page 15859;
- 2. Right Of Refusal executed by Peggy M. Stivers and Robert Sloan III, recorded August 8, 1980, in Vol. M-80 at page 14865; and
- 3. Right Of Refusal executed by Peggy M. Stivers and Jacqueline Jon Sloan, recorded August 8, 1980, in Vol. M-80 at page 14866;

are hereby Amended in the following particulars only, to-wit:

Paragraph C of each of the Agreements listed above is revoked and is hereby replaced with the following paragraph:

"C. In the event that one of the Grantees desires to sell his or her interest in all or any portion of the property described in the said Deed, then the selling Grantee shall give the remaining Grantees written Notice of any bona-fide offers which are acceptable to him and allow the remaining Grantees 60 days to deliver to the Selling Grantee a written offer to purchase the interest upon the same terms and conditions as contained in the bona-fide offer. In the event that remaining Grantees fail to present an offer within the 60-day period, the Selling Grantee may enter into an Agreement to sell his interest upon the same terms and conditions to the said bona-fide offer or to any other person or party so long as the sale is consummated within $90\ \mathrm{days}$ after the expiration of the $60\mathrm{-day}$ period."
