WATER SERVICE EXCHANGE AGREEMENT

THIS WATER SERVICE AGREEMENT entered into between RODNEY R. LYON and MARIE M. LYON, husband and wife, hereinafter called Owners, and SHASTA VIEW IRRIGATION DISTRICT, hereinafter called District,

WHEREAS, Owners own the following described lands:

- (a) Located within the boundaries of Shasta View Irrigation District, Klamath County, Oregon, to-wit:
SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 35, Township 40 S., R 12 EWM; and
W $\frac{1}{2}$ NW $\frac{1}{4}$ Sec. 2, Township 41 S., R 12 EWM.

Called Parcel 1 Herein;

- (b) Located outside the District boundaries of Shasta View Irrigation District in Klamath County, Oregon, to-wit:
NE $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 34 and NW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 35, Township 40 S., R 12, EWM.

Called Parcel 2 herein.

WHEREAS, Owners are desirous to place two center pivots or other type of sprinkler irrigation system for irrigation upon said lands, one center pivot or sprinkler system to be supplied water from Shasta View Irrigation District which would overlap lands outside the District, and the other center pivot or sprinkler system to be supplied water from a well located outside the District which would overlap District lands;

WHEREAS, approximately 80 acres outside the District will be supplied water from Shasta View Irrigation District and approximately 80 acres of District lands will be supplied water from Owners' well;

NOW, THEREFORE, the parties mutually agree:

1. Owners may irrigate the lands outside the District described as Parcel 2 from water supplied for the center pivot, or sprinkler system from Shasta View Irrigation District in exchange for,
2. Owners irrigating the lands located within the District described as Parcel 1 from water supplied for the center pivot or sprinkler system from the well of owners;
3. This agreement shall run with the land and be binding upon heirs, assigns and successors.
