Lot 3 D in Block 5 of Railroad Addition to the City of Klamath Falls, Oregon.

Lots 3 A, 3 B, and 4A in Block 5 of Railroad Addition to the City of Klamath Falls, Oregon.

Lots 3 C and 4 D in Block 5 of Railroad Addition to the City of Klamath Falls, Oregon.
