KNOW ALL MEN BY THESE PRESENTS, That SPRAGUE RIVER PINES, INC., an Oregon Corporation,

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by DEE M. McLEMORE, WILLIAM P. WAMPLER and ROBERT P. ELLINGSON, JR. as tenants in common, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Grantees to take an undivided one-third interest each in and to the following-described real property in Township 34 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon:

Section 21: All of the SE $\frac{1}{4}$ lying Easterly of the Sprague River;

Section 21: Portion E $\frac{1}{2}$ E $\frac{1}{2}$, containing 5.19 Acres;

Section 22: All of the SW $\frac{1}{4}$;

Section 27: All of the N $\frac{1}{2}$ NW $\frac{1}{4}$ and the SW $\frac{1}{4}$ NW $\frac{1}{4}$;

Section 28: All of the NE $\frac{1}{4}$ lying Easterly of the Sprague River;

which now includes Tracts Nos. 1029 and 1107 of Sprague River Pines.
