R E S O L U T I O N

WHEREAS, on the 8th day of November, 1980, CECIL E. LAYMAN and BARBARA A. LAYMAN conveyed to Klamath County, Oregon certain property for public road purposes described as follows:

Parcel 1. A strip of land 60 feet in width, being 30 feet on either side of a centerline which centerline is the north boundary of the Southwest Quarter of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section 13, Township 23 South, Range 9 East, Willamette Meridian, Klamath County, Oregon, and which strip of land extends from the west boundary to the east boundary of said Southwest Quarter of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of NE $\frac{1}{4}$).

Parcel 2. A strip of land 60 feet in width, being 30 feet on either side of a centerline which centerline is the west boundary of the East Half of the West Half of the Northeast Quarter (E $\frac{1}{2}$ of W $\frac{1}{2}$ of NE $\frac{1}{4}$) of Section 13, Township 23 South, Range 9 East, Willamette Meridian, Klamath County, Oregon, and which strip of land extends from the south boundary of said Northeast Quarter to the north boundary of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$) of said Section 13.

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session the 13th day of January, 1981, deemed it to be in the best interest of said County to accept the above described property for public road purposes;

IT IS THEREFORE ORDERED AND RESOLVED, that the above described property conveyed to Klamath County, Oregon by CECIL D. LAYMAN and BARBARA A. LAYMAN on the 8th day of November, 1980 shall be accepted as a public road right-of-way.
