RESOLUTION

WHEREAS, on the 25th day of November, 1980, KENNETH ENGSTROM and MARGARET ENGSTROM conveyed to Klamath County, Oregon, certain property for public road purposes described as follows:

Parcel 1: A strip of land 30 feet in width, the North boundary of which is the North boundary of the Southwest Quarter of the Southwest Quarter of the Northeast Quarter (SW<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub>) of Section 13, Township 23 South, Range 9 East, Willamette Meridian, in Klamath County, Oregon, extending from the East boundary to the West boundary of said Southwest Quarter of the Southwest Quarter of the Northeast Quarter (SW<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub>).

Parcel 2: A strip of land 30 feet in width, the East boundary of which is the East boundary of the Southwest Quarter of the Southwest Quarter of the Northeast Quarter (SW<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub>) of Section 13, Township 23 South, Range 9 East, Willamette Meridian, in Klamath County, Oregon, extending from the South boundary to the North boundary of said Southwest Quarter of the Southwest Quarter of the Northeast Quarter (SW<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub>).
