## R E S O L U T I O N

WHEREAS, on the 17th day of December, 1980, KEITH K. STRAIN, JANICE L. STRAIN, and KENNETH W. COFFMAN conveyed to Klamath County certain property for public road purposes described as follows:

Parcel 1: A strip of land 30 feet in width, the South boundary of which is the South boundary of the Northwest Quarter of the Southwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section 13, Township 23 South, Range 9 East, Willamette Meridian, Klamath County, Oregon, extending from the East boundary to the West boundary of said Northwest Quarter of the Southwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ).

Parcel 2: A strip of land 30 feet in width, the East boundary of which is the East boundary of the Northwest Quarter of the Southwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section 13, Township 23 South, Range 9 East, Willamette Meridian, Klamath County, Oregon, extending from the South boundary to the North boundary of said Northwest Quarter of the Southwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ).

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session the 13<sup>th</sup> day of January, 1981, deemed it to be in the best interest of said County to accept the above described property for public road purposes;

IT IS THEREFORE ORDERED AND RESOLVED, that the above described property conveyed to Klamath County, Oregon by KEITH K. STRAIN, JANICE L. STRAIN, and KENNETH W. COFFMAN on the 17th day of December, 1980 shall be accepted as a public road right-of-way.
