EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this <u>17th</u> day of <u>February</u>, 1981, by and between WEYERHAEUSER COMPANY, a Washington corporation, herein called "Weyerhaeuser," and the STATE OF OREGON, acting by and through its Board of Forestry, herein called "State," WITNESSETH:

Whereas, on the 25th day of May, 1978, Weyerhaeuser and the State entered into an easement exchange, hereinafter called Original Agreement, which was recorded in the records of Klamath County, Oregon, on the 30th day of May, 1978, in Volume M78 at page 11354, Deed Records. Said Original Agreement is hereby supplemented as follows:

A. Weyerhaeuser for and in consideration of a payment of Ten Dollars (\$10.00) and other valuable consideration, hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over and along rights of way thirty (30) feet in width, over and across the $S_{2}^{1}SE_{4}^{1}$ of Section 32, Township 32 South, Range 7 East, W.M., in Klamath County, Oregon being fifteen (15) feet on each side of the centerline of a road or roads located approximately as shown in red on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

Provided, however, thirty (30) days prior to any reconstruction and/or betterment of said road shown in red on Exhibit A on Weyerhaeuser lands, State will submit to Weyerhaeuser a written request for joint review of the proposed project. Said project will be conducted in accordance with the provisions of the approved plan of operations and with the Federal, State and/or local rules and regulations, governing such operations, in force at the time the project is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Agreement shall remain in full force and effect.
