SAID RIGHT-OF-WAY TO BE 10 FEET WIDE, 5 FEET EACH SIDE OF CENTERLINE.

"FOR THE INSTALLTION OF AN OVERHEAD ELECTRICAL CIRCUIT, AS MORE PARTICULARY SHOWN ON EXHIBIT "A" ATTACHED HERETO AND BY THIS REFERENCE MADE A PART HEREOF."

All rights hereunder shall cease if and when such line shall have been abandoned.
