Klamath County Planning Findings of Fact and Order

7 A hearing was held in this matter at Klamath Falls, 8 Oregon, on December 10, 1980, pursuant to notice given in con-9 formity with Ordinance No. 35, Klamath County, before the Klamath 10 County Assistant Hearings Officer, James R. Uerlings. The appli-11 cant was present. The Klamath County Planning Department was 12 represented by Jonathan Chudnoff. The Hearings Reporter was 13 Barbara Thomson.

14 Evidence was presented on behalf of the Department and 15 on behalf of the applicant. There were no adjacent property 16 owners present who stated they had objections to the proposed 17 Conditional Use Permit requested by the applicant.

25 The hearing was then closed, and based upon the evidence 26 submitted at the hearing, the Hearings Officer made the following 27 Findings of Fact:

FINDINGS OF FACT:

1 1. The site for the proposed use is adequate in size 2 and shape to accommodate said use and all yards, spaces, walls 3 and fences, parking, loading, landscaping and other features 4 required to adjust said use with the land and its use in the 5 neighborhood are present or will be adequately provided. 6 2. The site for the proposed use has adequate access 7 to streets and highways which are adequate in width and pavement 8 type to carry the quantity and the kind of traffic generated by 9 the proposed use. 10 3. The proposed use will have no adverse effect on 11 abutting property or the permitted use thereof. 12 4. No one testified in opposition to the Conditional 13 Use Permit requested by the applicant. 14 5. The granting of this permit is consistent with the 15 goals of L. C. D. C. 16 6. The following conditions imposed hereinbelow are 17 deemed necessary to protect the public health, safety, and 18 general welfare, 19 CONDITIONS: 20 1. Applicant shall obtain all necessary permits that 21 are applicable for operation of this facility from state, local, 22 and federal agencies. 23 There shall be no on-site sales of this merchandise. 24 The Hearings Officer, based on the foregoing Findings of 25 Fact, accordingly orders as follows: 26 That real property described as the 27 "parcel of land generally located on the corner of Clover Creek Road and Puckett Road, and more 28 particularly described as being in SEt of Section C.U.P. 80-44 Page -2-
