6 7 A hearing was held in this matter at Klamath Falls, Oregon, on January 14, 1981, pursuant to notice given in conform-8 9 ity with Ordinance No. 35, Klamath County, before the Klamath County Assistant Hearings Officer, James R. Uerlings. The applicant was present. The Klamath County Planning Department was represented by Jonathan Chudnoff. The Hearings Reporter was Barbara Thomson.

14 Evidence was presented on behalf of the Department and 15 on behalf of the applicant. There were no adjacent property 16 owners present who stated they had objections to the proposed Conditional Use Permit requested by the applicant. 17

FINDINGS OF FACT:

1 The site for the proposed use is adequate in size 1. and shape to accommodate said use and all yards, spaces, walls, 2 and fences, parking, loading, landscaping and other features 3 required to adjust said use with land and uses in the neighborhood 4 are present or will be adequately provided. 5 6 2. The site for the proposed use has adequate access to streets and highways which are adequate in width and pavement 7 type to carry the quantity and kind of traffic generated by the 8 9 proposed use. 10 The proposed use will have no adverse effect on 3. abutting property or the permitted use thereof. 11 12 The granting of the Conditional Use Permit is con-4. 13 sistent with the goals of L. C. D. C. 14 The Conditional Use Permit is approved subject to 5. the following conditions. 15 16 CONDITIONS: 17 Applicant shall follow plot plan illustrating where 1. 18 the business shall be conducted as shown on Applicant's Exhibit No. 1. 20 The majority of the sales generated by the home 2. occupation shall be done away from the home to avoid additional 21 22 traffic generated in the area. 23 The Hearings Officer, based on the foregoing Findings of 24 Fact, accordingly orders as follows: 25 The real property described as the 26 "parcel of land approximately two acres in size, generally located south of Michael Road approxi-27 mately 1,100 feet west of Jerry Road, generally being in the Antelope Meadows area, and more 28 particularly described as being in the NW4, NW4, C.U.P. 80-49 Page -2-
