

KNOW ALL MEN BY THESE PRESENTS, that the undersigned hereinafter called the Claimant, has performed labor upon and transported materials under an agreement between Claimant and CLINT WEBB, doing business as CLINT'S LOGGING, PACIFIC CHIP PRODUCERS and SAWDUST SERVICE, INC., and that said person or persons just named, at all times herein mentioned, had knowledge of the transportation of said materials; that said transportation took place on or between the 12th day of January, 1981, and the 26th day of January, 1981.
