Notice is hereby given that the undersigned claimant claims a lien upon all logs of all species branded with the brand of Wayne Dishman being marked with a D over a W, which were obtained, handled, logged and removed from claimant's real property in Klamath County, Oregon, and transported in Klamath County, Oregon, and are now lying in Klamath County upon the premises of Thomas Lumber Company whose mailing address is: P.O. Box 1883, Klamath Falls, Oregon 97601.

The Claimant, Lawrence R. Wershky, is the owner of the above described timber, logs and/or wood products cut and removed from claimant's property in Klamath County between December 17, 1980 and February 28, 1981, and hauled to the Thomas Lumber Company premises by Dean Lillie, Wayne Dishman, Steve Lillie, Grizzly Mining & Timber, Inc., their agents or employees, without the knowledge, consent or authority of claimant; 60 days have not elapsed since delivery of said logs to Thomas Lumber Company.

All timber logged and removed from claimant's land in Klamath County, Oregon, after December 11, 1980 was by trespass and conversion, totalling approximately 1.4 million board feet.
