AGREEMENT.

THIS AGREEMENT, Made and entered into this 9 day of February, 1981, by and between NEIL BARNWELL, hereinafter called "Barnwell", and KENNETH D. MASTEN, hereinafter called "Masten";

WITNESSETH:

WHEREAS, Barnwell is the owner of an agricultural well situate on Section 13, Township 39 South, Range 11½ E., W.M.; and

WHEREAS, Masten has approximately 25 acres of land situate in Section 18, Township 35 South, Range 11 E., W.M.; and

WHEREAS, Masten is not served by Horsefly Irrigation District nor by any other means on this small parcel of land, and is desirous of obtaining water until such time as he can obtain water rights; Now Therefore,

The parties being fully advised, IT IS AGREED AS FOLLOWS:

1. Masten shall be allowed to attach a main line to Barnwell's main line which abuts the Masten property and to obtain water therefrom to irrigate approximately 25 acres in Section 18, Township 39 South, Range 11 E., W.M.;

2. It is understood and agreed that Masten shall promptly apply to the State of Oregon to obtain water rights for this property from the well in question situate in the SE Quarter of Section 18, Township 39 South, Range 11 E., W.M.;

3. In consideration therefor, Masten agrees to pay as reimbursement for the costs of furnishing said water, the same price as the assessment for Horsefly Irrigation District during any such year in which water is obtained;

4. Masten agrees also to perfect water rights from other sources if at all possible.

Barnwell agrees to keep the main line in its present position or if moved to move it so as not to interfere with the right of Masten to attach to said main line.

Masten agrees to keep and maintain his pipes and irrigation equipment in order so that there will be no leakage or seepage that may cause injury to the land of Barnwell.

This agreement shall be construed as an absolute right
