- 5.7 Any partnership or corporation that has signed the Note or this Trust Deed, or is a guarantor or surety for the Note, dissolves or terminates its existence.
- 6. After default, Lender may take any one or more of the following actions at Lender's option, without notice to Owner:
 6.1 Lender may continue to charge interest on the unpaid Loan Amount at the rate(s) of interest specified in the Note.
- 6.2 Lender may declare the entire unpaid amount owed on the loan, including interest, to be due and payable immediately. 6.3 Lender may, with respect to all or any portion of the Property, exercise the right to foreclose this Trust Deed.
- 6.3.1 In accordance with applicable law, Lender may proceed to foreclose this Trust Deed by advertisement and sale, or foreclose this Trust Deed by suit in equity in the manner provided 6.3.2 If Lender forecloses by advertisement and sale, Lender or the Trustee shall execute and record its written notice of default and its election to sell the Property to satisfy the amount owed on the Note, whereupon the Trustee shall fix the time and place of sale, give notice thereof, and otherwise proceed to foreclose this Trust Deed by advertisement and sale in the manner provided by applicable law. 11. If all or any part of the Property is condemned, Lender may at its election require that all or any portion of the net proceeds of the award be applied on the Note.
