23 bonds of Matrimony heretofore existing between the Plaintiff and 24 the Defendant are dissolved and forever held a nullity. 25 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Plaintiff is awarded the care; custody and control of the minor children of

the parties, namely; Jay Merton Stein, born October 10, 1964 and Jennie Lee Stein, born May 5, 1968, subject to the reasonable visitation rights of the Defendant herein after reasonable notice has been given to the Plaintiff. 1 - DECREE
