AMENDMENT NO. 10 TO THE RIGHT-OF-WAY AND ROAD USE AGREEMENT  
(RWA NO. M-690) AND O&C LOGGING ROAD RIGHT-OF-WAY PERMIT (RWA NO. M-690)

Agreement between the UNITED STATES OF AMERICA, acting by and through its agency, Department of the Interior, Bureau of Land Management, and WEYERHAEUSER COMPANY, a Washington corporation.

W I T N E S S E T H:

WHEREAS, on June 19, 1963, the parties hereto entered into Right-of-Way and Road Use Agreement RWA No. M-690 recorded in Volume 547, Page 588 in the Deed Records of Jackson County, Oregon, and in Volume 346, Page 367 in the Deed Records of Klamath County, Oregon, and the United States executed O&C Logging Road Right-of-Way Permit (Blanket) (RWA No. M-690).

Said Agreement and permit were amended by an instrument titled Amendment #1, executed December 4, 1963, and recorded in Volume 350, Page 362, Deed Records of Klamath County, Oregon, and also amended by an instrument titled Amendment #2, executed May 3, 1966, and recorded as Document No. 66-05956 in the Official Records of Jackson County, Oregon, and also amended by an instrument titled Amendment #3, executed July 12, 1967, and recorded as Document No. 67-07278 in the Official Records of Jackson County, Oregon, and also amended by an instrument titled Amendment #4, executed September 27, 1967, and recorded as Document No. 67-09937 in the Official Records of Jackson County, Oregon, and also amended by an instrument titled Amendment #5, executed April 29, 1970, and recorded as Document No. 70-05318 in the Official Records of Jackson County, Oregon, and also recorded in Volume M-70, Page 4750, Deed Records of Klamath County, Oregon, and also amended by an instrument titled Amendment #6, executed September 15, 1970, and recorded in Volume M-70, Page 8428, Deed Records of Klamath County, Oregon, and also amended by an instrument titled Amendment #7, executed February 20, 1973, and recorded in Volume M-73, Page 2551, Deed Records of Klamath County, Oregon, and also amended by an instrument titled Amendment #8, executed February 12, 1974, and recorded in Volume M-74, Page 2828, Deed Records of Klamath County, Oregon, and also amended by instrument titled Amendment #9 executed May 6, 1975 and recorded in Volume M-75, page 5728, Deed Records of Klamath County, Oregon and as 75-07085 in the Official Records of Jackson County, Oregon.

WHEREAS, the parties hereto desire to amend such right-of-way and road use agreement and permit to include and exclude certain land.

NOW, THEREFORE, the parties hereto do mutually agree:










