16 Grantees, as such Trustees, their successors, grantees and assigns forever.

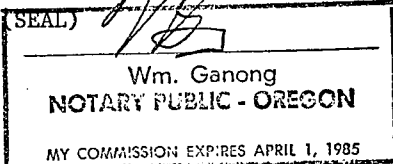
