NOW, THEREFORE, THIS INDENTURE WITNESSETH, that for and in consideration of the grant hereinafter made by State, OWNER does hereby transfer and relinquish unto State, its successors and assigns, her access rights to and from the Easterly side of the relocated The Dalles-California Highway opposite said Station 47+10 granted by said Indenture and said deed recorded on August 16, 1962. Owner represents and warrants that no one, other than Owner, is using or entitled to use the access rights herein relinquished. STATE, in consideration of the relinquishment and warranties herein made, does grant and convey unto OWNER, her heirs and assigns, access rights to and from the Easterly side of said highway, opposite said Station 45+75 in a width of 25 feet and subject to all of the terms, conditions, and the use limitations set out in said deed recorded January 14, 1952.

Except as modified herein and by said Indenture of Access, said deed recorded January 14, 1952, shall remain in full force and effect, and the access rights herein granted shall be subject to all of the provisions affecting the access contained in said deed.
