That they are lawfully seized of said premises in fee simple, have good right and lawful authority to convey and mortgage the same, and that said premises are free from encumbrance; and each of the mortgagors will warrant and defend the same forever hereof, but shall run with the land.

To pay all debts and mone; secured hereby when due.
