The site for the proposed use is adequate in size and shape to accommodate said use and all yards, spaces, walls and fences, parking, loading, landscaping and other features required to adjust said use with land and uses in the neighborhood are present or will be adequately provided.

- The site for the proposed use has adequate access to streets and highways adequate in width and pavement type to carry the quantity and kind of traffic generated by the proposed use.
- The proposed use will have no adverse effect on abutting property or the permitted use thereof.
- 4. No one testified in opposition to the granting of this Conditional Use Permit.
- The granting of this Conditional Use Permit is consistent with the goals of the L. C. D. C.
- The following Conditions are deemed necessary to protect public health, safety, and general welfare.

CONDITIONS:

- 1. Applicant shall follow map as submitted, Applicant's Exhibit No. 1.
- 2. Applicant shall place at least a six-foot fence with the appropriate barbed wire as a safety measure around the facility.
- Applicant, if necessary, shall cooperate with any county or local agencies in improving roads providing access to the area.
- 4. If necessary, applicant shall obtain the necessary vacation approval for the alley that bisects the property.
