AN ORDINANCE VACATING PORTIONS OF ALANDALE AND APPLEWOOD STREETS BETWEEN EBERLEIN AVENUE AND OUD ORCHARD MANOR, ALLE IN THE CITY OF KLAMATHEFALLS, OREGON, AND DECLARING AND EMERGENCE AND EMERICAN ENGLISHED AND EMERGENCE AND EMPORT AND EMERGENCE AND EMPORT AND EMERGENCE AND EMERGENCE AND EMERGENCE AND EMPORT AND EMERGENCE AND EMPORT AND EM

WHEREAS, on April 6, 1970, pursuant to Resolution No. 1797, the Common Council of the City of Klamath Falls, Oregon, held a public hearing on a proposal to vacate those portions of Alandale and Applewood Streets between Eberlein Avenue and Old Orchard Manor, all in the City of Klamath Falls, Oregon; and

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is to the best interest of the City that said streets be vacated; at therefore

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

## Section 1.

Those portions of Alandale and Applewood Streets described below as parcels and 2 respectively be, and the same are hereby vacated.

## Parcel 1.

A portion of Tract 1 as described in a Warranty Deed from Alfred D. Collier and Ethel F. Collier to Klamath County, recorded in Volume 137, page 542 of Deeds, on file in the Office of the Clerk of Klamath County, Oregon and more particularly described as follows: Beginning at a point on the northerly right-of-way line of Eberlein Avenue which lies South 0° 28' East along the centerline of Washburn Way a distance of 1223.7 feet and North 89° 16' East a distance of 235 feet from the basection corner common to Sections 33 and 34, Twp385, R9E, W.M. in Klamath County, Oregon, and running thence; North 0° 28' West parallel to the centerline of Washburn Way a distance of 290.0 feet to a point; said point being the S.E. corner of Lot 30, "Old Orchard Manor" Addition, Klamath County, Oregon; thence North 89° 16' East a distance of 60.0 feet to a point; said point being the S.W. corner of Lot 31 of said "Old Orchard Manor" Addition; thence South 0° 28' East parallel to the centerline of Washburn Way a distance of 290.0 feet to a point on the Northerly right-of-way line of Eberlein Avenue; thence South 89° 16' West along the northerly right-of-way line of Eberlein Avenue a distance of 60 feet to the point of beginning and containing 0.40 acres more or less.

## Parcel 2.

A portion of Tract 2 as described in a Warranty Deed from Alfred D. Collier and Ethel F. Collier to Klamath County, recorded in Volume 137, page 542 of Deeds, on file in the Office of the Clerk of Klamath County, Oregon and more particularly described as follows: Beginning at a point on the northerly right-of-way line of Eberlein Avenue, which lies South 0° 28' East along the centerline of Washburn Way, a distance of 1223.7 feet and North 89° 16' East, a distance of 495 feet from the 3 section corner common to Sections 33 and 34, Twp38S, R9E, W.M. in Klamath County, Oregon and running thence North 0° 28' West parallel to the centerline of Washburn Way a distance of 260 feet to a point; said point being South 0° 28' East, a distance of 30.0 feet from the S.E. corner of lot 60, of "Old Orchard Manor" Addition, Klamath County, Oregon; thence running North 89° 16' East, a distance of 60.0'
